Website Terms

When you access this site you acknowledge that you have read and agree to the terms described below. You should refrain from placing any order and exit the site if you do not agree to the terms discussed here.

Any contract arising from this site is governed by the laws of New Zealand. EasyBarrow Ltd will deliver goods only within New Zealand and payment of the full amount due is to be made in NZ currency.

From time to time products described on the site may not be available and product may be added to or removed from the site. While EasyBarrow Ltd does not accept liability for any loss arising, every effort will be made to keep the information up to date and accurate.

Purchasing

Products may be ordered by following the instructions on the Purchasing page of this site.

Prices may increase or decrease from time to time and all prices quoted include Goods and Services Tax. Payment is to be made in New Zealand dollars for the full amount due.

Delivery is to physical addresses within New Zealand only. We are unable to courier to a PO Box address. Goods are at our risk until delivered to you or your shipping agent.

We will endeavor to deliver your purchase within 3 to 4 working days after receiving your order. Some addresses i.e. Rural Delivery may be dependent on the local courier's schedule.

Please note that the courier requires a signature to confirm delivery. If nobody is home at the time of delivery, the courier will leave a calling card in the mailbox and alternative delivery arrangements can be made.

We cannot guarantee to relay specific delivery instructions to our courier, however we will make endeavors to do so.

Delivery charges are based on the weight and size measurements of the product purchased and shown as a separate item. Delivery will be by courier elected by EasyBarrow Ltd.

No order will be accepted for delivery outside New Zealand.

If you elect to pay by credit card your credit card information is strictly confidential. If EasyBarrow Ltd is unable to deliver any items, your card will be credited with the full cost and delivery charge for that item debited when the order was placed.

Accepted credit cards are: Visa and MasterCard.

Title and Risk

Your order is not binding until accepted by EasyBarrow Ltd. Goods are at our risk until delivered to you, or until a third party or delivery agent has possession of that item.

Title in the products does not pass until we receive payment in full for any and all purchases and/or other funds that are owed to EasyBarrow Ltd.

Cancellation and Product Return

You may cancel your order without charge at any time up to the time of dispatch of goods to your address. Any charge to your credit card will be credited.

You may return goods if they are faulty or damaged, or where the goods delivered are not those that you ordered. You must return the goods in their original condition and packaging, and they must be received by us within 30 days of delivery. You may chose to have the goods replaced without further charge, or your credit card will be credited with the cost of the goods including the cost of handling and delivery.

All goods returned must be in original condition and packaging, together with the delivery docket.

Warranties

Unless the goods are acquired for business purposes, EasyBarrow Ltd will repair or replace any goods which fail to comply with any guarantee contained in the Consumer Guarantees Act 1993.
